# Sub: Fuel and Power Purchase Price Adjustment (FPPPA) calculation for Q3 of FY23

### Dear Sir,

With reference to the above subject, we hereby submit the calculation of FPPPA for Q3 of FY23 duly certified by the Auditors, considering power purchase cost and FPPPA formula approved by Hon'ble GERC vide its order dated 31.03.2022 in the Petition No. 2036 / 2021.

As per Auditor's certificate, FPPPA charges come to Rs. 0.33 per unit. Accordingly, we may recover FPPPA charges at Rs. 0.33 per unit during Q4 of FY23.

MUL has started to recover the FPPPA charges of Rs. 0.14 per unit from billing month of October, 2022 and requested Hon'ble Commission to approve Rs. 0.20 per unit for recovery of FPPPA charges in Q3 of FY23 which came for Q2 of FY23 as per approved FPPPA formula. Accordingly, Hon'ble commission has directed to allowed to recover the under-recovery of Rs. 0.06 per unit from the billing month of January, 2023 via mail dated 18.01.2023 (Annexure-2).

As per GERC Tariff Order dated 31.03.2022, any levy of fuel surcharge beyond 10 Paisa per unit requires prior approval of Hon'ble GERC.

Since, increase in FPPPA for the 3rd Quarter of FY 2022-23 is 13 Paisa per unit (Increase from Rs. 0.20 to Rs. 0.33 per unit), which is in excess of 10 Paisa per unit and therefore, we request Hon'ble Commission to accord approval for the recovery of Rs. 0.33 per unit of Q3 of FY23 for Q4 billing of FY23.

Meanwhile, we will start to recover FPPPA charges at Rs. 0.30 (Rs. 0.14 + Rs. 0.06 + Rs. 0.10) from the billing month of January, 2023 till receipt of approval from Hon'ble GERC.

Any difference in actual power purchase cost with respect to approved power purchase cost will be considered in truing up of FY23.

# Sub: Fuel and Power Purchase Price Adjustment (FPPPA) calculation for Q2 of FY22-23

### Dear Sir,

With reference to the above subject, we hereby submit the calculation of FPPPA for Q2 of FY22-23 duly certified by the Auditors, considering power purchase cost and FPPPA formula approved by Hon'ble GERC vide its order dated 31.03.2022 in the Petition No. 2036 / 2021.

As per Auditor's certificate, MUL has worked out FPPPA of Rs. 0.20/Unit for Q2 of FY 2022-23 as against present recovery of FPPPA of Rs. 0.04/Unit. Thus, there is an increase of Rs. 0.16/Unit (Rs. 0.04 to Rs. 0.20 per Unit) in FPPPA charges for Q2 of FY22-23.

As per GERC Tariff Order dated 31.03.2022, any levy of fuel surcharge beyond 10 Paisa per unit requires prior approval of Hon'ble GERC. Since, increase in FPPPA for the 2<sup>nd</sup> quarter of FY 2022-23 is 16 Paisa per unit (Increase from Rs. 0.04 to Rs. 0.20 per unit), which is in excess of 10 Paisa per unit, approval of Hon'ble Commission has been sought for recovery of FPPPA of Rs. 0.20 per unit of Q2 of FY22-23 for Q3 billing of FY22-23.

Meanwhile, we will start to recover FPPPA charges at Rs. 0.14 (Rs. 0.04 + Rs. 0.10) for the billing month of November 2022 (Bill shall be raise on 1st November 2022 onwards) till receipt of approval from Hon'ble GERC.

Any difference in actual power purchase cost with respect to approved power purchase cost will be considered in truing up of FY22-23.
